2. That besides the above, two persons shall be nominated as the trustees to the trust by the Sanatam Dharam Sabha, Punjabi Bagh (Regd.) Delhi who shall be the president and general secretary of the said Sabha. In case the President and General Secretary of the Sabha happen to be life trustees of the trust, the Sabha in its Annual General body meeting shall have the right to nominate any other person as its nominee in the trust.

- j. To provide training programmes for teachers and other staff whenever possible.
- k. To establish institutions, centres, including houses, research laboratories to carry out above objectives and purposes.
- l. **AND GENERALLY** to do all other acts, deeds and things as may be conducive to the attainment and furtherance of any other object of public utility not involving the carrying on of any activity for profit and without any distinction of caste, creed and religion.

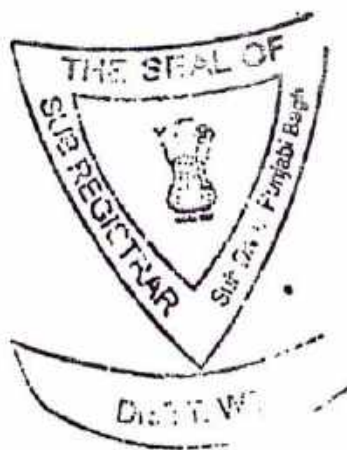

6. It is hereby declared that no part of the trust property or its income shall be applied for any purpose other than for the objects of the trust as understood under the Income Tax Act for the time being in force, and the surplus funds if any of the trust shall be invested as per the provisions of the Income Tax Act, 1961.

7. The number of trustees shall not be less than five and not more than nineteen excluding 2 representative of Sanatan Dharam Sabha, East Punjabi Bagh. The trustee (except those nominated by the Sanatan Dharam Sabha Punjabi Bagh (Regd.) shall be trustee for their life time but any trustee may resign by giving notice in writing to the co-trustees.

8. The General management and control of the trust properties and its affairs shall be vested in the trustees and the trustees shall have power to do all such acts as may be considered necessary for the benefit of the trust and/or management of the properties and affairs.

9. Without prejudice to any of the powers that the Trustees may have under any law for the time being in force or to their general powers the management, the trustees shall have the following powers:-

a. To manage the Trust and the Trust fund and to do all acts, deeds and things necessary for the preservation, maintenance and management of trust and the affairs relating thereto or connected therewith including the making of rules and regulations from time to time in regard to the same.

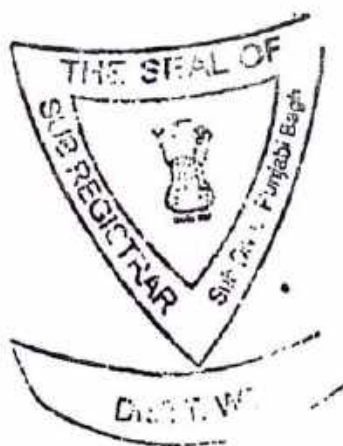

- b. To Manage of trust fund by accruing movable property in the Trust Name.
- c. To take on rent or lease purchase or construct building for schools in any movable or immovable property and to construct, and alter, demolish, maintain, sell, dispose off alienate or otherwise deal with any property moveable or immovable comprising the Trust Fund, for the achievement of the objects of the trust.
- d. To let out any moveable or immovable property comprised in the trust fund for such period and at such rent on such terms and conditions as the trustees in their discretion may think fit.
- e. To acquire purchase sell, convert, change, transfer, transpose or otherwise deal with all or any of the investment including shares, stocks, debentures, bond, securities belonging to the trust or representing the trust fund and to reinvest the same as the trustees may deem fit and proper in accordance with the provisions of Income Tax Act.
- f. This Gift Deed executed this 1st October, 1964 between the Refugee Cooperative Housing Society Ltd., Punjabi Bagh Delhi-34 a Society registered under the Bombay Cooperative Societies Act as extended to Delhi hereinafter called the Grantor through its Secretary of the one part and Shri Sanatan Dharam Sabha Punjabi Bagh (Regd) a society of members of the Refugees Cooperative Housing Society Ltd., through its Secretary Shri Girdhari Lal s/o Shri Kishan Chand resident of 1/44, Punjabi Bagh, Delhi-34 hereinafter called the Grantee of the Second Part.

WHEREAS it is agreed and declared as follows:-

WHEREAS the Chief Commissioner Delhi by his notification No.F.15(31) 50 M.L.T. dated 30-12-1950 in exercise of the powers conferred on him by the Resettlement of Displaced Persons (Land Acquisition) Act, 1948 (LX of 1948) acquired the land for the Colony of the Grantor Society and the grantor Society is the owner of the following school site plot.





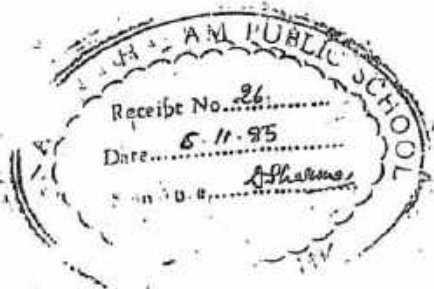
