

It is hereby declared that no part of the trust property or its income shall be applied for any purpose other than for the objects of the trust as understood under the Income Tax Act for the time being in force, and the surplus funds if any of the trust shall be invested as per the provisions of the Income Tax Act, 1661.
- 7. The number of trustees shall not be less than five and not more than sincteen excluding 2 representative of Sanatam Dharam Sabha, East Punjabi Bagh. The trustee (except those nominated by the Sanatan Dharam Sabha Punjabi Bagh (Regd.) shall be trustee for their life time but any trustee may resign by giving notice in writing to the co-trustees.
- 6. The General management and control of the trust properties and its entains until be vested in the trustees and the trustees shall have power to do all such acts as may be considered necessary for the benefit of the trust and/or management of the properties and affairs.
- 9. Without prejudice to any of the powers that the Trustees may have under any law for the time being in force or to their general powers the management, the trustees shall have the following powers:-






